Schedule of Events

Opening Number - All contestants will need a white button-up shirt and either **WHITE OR BLACK** shorts, white socks and white tennis shoes.

Modeling - 2 minutes or less. Long or short dress (age appropriate) - Makeup (age appropriate) Freestyle modeling, contestant should appear poised, but natural on stage. Music will be provided.

NEW!!! - On stage interview/question. (Don't Worry!! This is for fun!! No Judging!!)

Talent - 2 minutes or less. Music **MUST BE** on CD, in plastic case and labeled with name and phone number on both CD and CD Case. No pre-taped entries allowed. Pianos will not be available at facility on day of Pageant. Vocal entries may have no vocal melody recorded, although harmony is allowed. **NO** hazardous props may be used. Production CDs **MUST BE** submitted in duplicate with completed application. (SEE PRODUCTION SHEET ENCLOSED)

Lunch Break - 45 Minutes Food will be available for purchase in the school commons.

Commercial - 2 minutes or less. Contestants are to promote any festival event, festival theme, pageant theme and festival entertainment. Props and costumes are encouraged. Same rules apply in commercial as in talent. Body mics will be allowed during this phase.

2010 Festival Theme - "Peace, Love & Popcorn"

2010 Pageant Theme - "Teeny Pop Gets Groovy"

Awards - All contestants are to be dressed in modeling attire for awards presentation.

Photogenic - This category has no bearing on the Pageant results. Photos are judged in closed session. This event is optional at an additional fee of \$10.00 PREPAID with application - **NO SAME DAY ENTRIES WILL BE PERMITTED. DO NOT** submit photo with application. An 8 X 10 (size required) photo to be turned in on Pageant day. **DO NOT SUBMIT** framed photos. Photos **MUST BE LABELED** with contestant name and AGE on back of photo. There will be a winner in each age division and an overall winner.

ATTENTION: There will be **NO VIDEO CAMERAS ALLOWED** in the auditorium. There will be **NO EXCEPTIONS** to this rule. Our production is professionally recorded. Order forms can be found within the application.

MUSIC AND PRODUCTION INFORMATION MISS TEENY POP 2010

It is our goal to give your contestant the Best possible quality production; therefore we have implemented the following production requirements:

- All talent & Commercial productions must be on CD...cassette tapes will not be accepted. This includes background music tracks and any sound effects that you will be using.
- You must give us 2 copies of your production CD.
- All CD's must be clearly marked with the contestants name, phone number, name of songs and/or track number you will be using.
- All music or sound effects must be of high quality production and must be on the same CD. If you are using multiple sound effects, they must already be edited and ready to use when final CD's are turned in.
- All production music must be turned in to Teeny Pop no later than July 21, 2010. NO EXCEPTIONS!! A \$25.00 late fee will be assessed
- Talent production music must be under 2 minutes.
- Contestants are welcome to produce their own CD's but quality & backup on CD must be approved by our production
