2. By signing this application and contract and submitting it to the Marion Popcorn Festival's Miss Teeny Pop pageant, the contestant's legal guardian represents and agrees that all facts and representations contained in this contract and application and attachments are true and accurate.
3. The contestant is between the ages of 6-12 on pageant day, is in good health, and can participate in the competition without causing a health risk to myself or anyone else.
4. I authorize the use of my child's name, likeness, photographs, and pictures for advertising, news, and promotional uses.
5. I understand that if this application was received via electronic mail, that I may not make any alterations to this official document. I will be bound by the rules and regulations as stated in the official Miss Teeny Pop document in its entirety.

II. Obligations and Agreements

All photographs, videotapes, audiotapes, motion picture films, or other recordings or reproductions made of my child, whether "still" or "live", and my name, likeness, photographs, pictures, physical depiction, title, and endorsements rights as a contestant, participant, or title holder remain the property of the Marion Popcorn Festival Scholarship Program in perpetuity.

III. Entry Fees

All applicants are required to pay an \$85.00 entry fee to participate in the Miss Teeny Pop Pageant. Any contestant with \$200.00 in sponsorships or who sells \$200.00 in good luck ads will have their entry fee waived. The optional photogenic competition is \$10 for 1 photo/\$15 for 2 photos/\$20 for 3 photos/\$25 4 photos.

All Fees are due and payable with the complete application packet. The application packet must be postmarked on or before Thursday, July 21, 2022 for the application to be accepted.

I understand that if my child is to receive the title or place as a runner-up in the competition that the facts of eligibility will continue to remain effective until the 2023 pageant date.

Miss Teeny Pop Competition and General Appearance Rules

1. The Marion Popcorn Festival Miss Teeny Pop Pageant Committee designs, plans, and facilitates the rules and competition for Miss Teeny Pop competition.
2. Three to five people will be assigned to judge the competitions based on the rules of competition as defined by the Miss Teeny Pop Pageant committee.
3. Two people will be assigned to audit the judge's scores. The decision of the judges is final. Any questions concerning the judging will be directed to the judge's chairperson.
4. Only one person is allowed backstage with the contestant. One parent will be given an ID badge to be worn while backstage with their child. This badge can be given to another adult to go backstage but at no time can there be more than one person per contestant in the dressing room or on stage.
5. The Marion Popcorn Festival's Miss Teeny Pop pageant committee, the Marion Popcorn Festival, and River Valley Local Schools are not responsible for accidents or injuries, nor are they responsible for lost or stolen personal items.
6. Poor attitudes, disruptive behavior, or discipline problems will not be tolerated, by contestants or family members.
7. I understand that inappropriate social media behavior will not be tolerated by the Marion Popcorn Festival Miss Teeny Pop Pageant. I also understand that if any such materials are brought to the attention of the Marion Popcorn Festival Teeny Pop Pageant that I am in danger of losing my title. I agree that it is at the sole discretion of the Marion Popcorn Festival Teeny Pop Pageant to determine the consequences of any such action.
8. The titleholder and her court will have their crowns and sashes available to wear at all events. No flash still photography will be permitted during the competition. If someone is videotaping, no lighting will be allowed and must be set to not interrupt the official program or block the view of any audience members. **NO BACKSTAGE PHOTOGRAPHY WILL BE PERMITTED.** There will be time allotted at the end of the competition for photos of the contestants. All press has first priority to photographs immediately following the competition due to publishing deadlines.

Modeling-20% This category is a chance for the girls to show their personality to the judges through poise, confidence, and composure with age-appropriate dress and make-up. Music for this category will be provided.

Talent-50% Music for this portion needs to be pre-edited and handed in with the application. Please provide a flash drive with the contestant's name as well as the name of the song.

Popcorn Comercial- 30% This category is a chance for the girls to sell the Popcorn Festival to the audience in a commercial of their choice. The commercial should be something that promotes the Popcorn Festival, popcorn, and/or the theme – “Poppy Goes to Space!” There will be no description read before this category, so it is important that the judges and audience can clearly understand the relevance to popcorn and the festival. Any music used for this portion must be pre-edited and handed in with the application. Any music for this portion should be included on the talent flash drive and be clearly labeled. **HAVE FUN WITH THIS CATEGORY**

Photogenic: This is an optional category. Bring a current 8x10 photo of your child with first name only on the back to registration on August 6th 2022. This photo can be color or black and white. This does not have to be a professionally taken photograph.

You may enter 1 photo for \$10, 2 photos for \$15, 3 photos for \$20, or 4 photos for \$25

Modeling, Talent, and Popcorn Commercial all have a 2-minute time limit. For every 30 seconds over the two-minute time limit, a 2 point penalty will be given to the contestant.
